AN ORDINANCE CREATING BAGUIO CITY EDUCATION COORDINATING COUNCIL (BCECC), DEFINING ITS FUNCTIONS AND APPROPRIATING FUNDS THEREOF.

SECTION 2. DECLARATION OF POLICY AND PRINCIPLES. – The Baguio City Education Coordinating Council (BCECC) thrives to establish a formidable education coordinating body to ensure better delivery of education services in the City of Baguio. Coordination among education bodies and other essential partner institutions surely results to more harmonious policies, up to date standards and aligned education outcomes.

SECTION 3. OVERALL MANDATES OF THE BAGUIO CITY EDUCATION COORDINATING COUNCIL (BCECC).

- a.** To take the lead in coordinating with the various education stakeholders. Stakeholders include government agencies and those from the private institutions;
- b.** To develop systems or pathways of collaboration among education stakeholders. Through this system, quality assurance in the delivery of Education Services within the City of Baguio is on check and assured;
- c.** To gather, collate, review and evaluate suggestions and recommendations from various education stakeholders. The data can be utilized as basis for possible introduction of education related measures;
- d.** To come up with a system of measuring the collective success rate of the education services in the City of Baguio. Through the set system, interventions could be initiated and/or introduced to further improve the quality of education services within the City of Baguio;

- a. To concomitantly serve as the City's Education Quality Assurance Team tasked to review and assess the state of education services for the past three (3) years as basis for coming up with tailor fit and more strategic and responsive education programs for the City of Baguio;
- b. To do local policy recommendations centered on enhancing the city's education related services that would further strengthen the hold of the City of Baguio as the center of quality education of the North;
- c. To spearhead capacity building programs involving education stakeholders that promote synergy, harmony and seamless cooperation geared towards vibrant Baguio City as an educational center;
- d. To recommend to the *Sangguniang Panlungsod* (City Council) of Baguio legislative measures for possible adoption covering and concerning the education sector; and
- e. May represent the education sector in the City Development Council (CDC).

SECTION 5. COMPOSITION. – The Baguio City Education Coordinating Council (BCECC) shall be composed of the following:

Ordinance No. 64-2021

AN ORDINANCE INSTITUTIONALIZING
THE VALUES RESTORATION/
ENHANCEMENT PROGRAM FOR THE
CITY GOVERNMENT OF BAGUIO AND
FOR OTHER PURPOSES.

SECTION 2. PURPOSE. –

The Baguio City Values Restoration/Enhancement Ordinance (BCVREO) endeavors to reorient public officials and employees towards nurturing positive Filipino Values alongside core values expected of government officials and employees as provided by law, and to promote a high degree of public service and governance in the City of Baguio.

SECTION 3. SCOPE. – This Ordinance shall cover all officials and employees of the City Government of Baguio, the barangays, the Sangguniang Kabataan, public schools, the Baguio City Police Office, the Bureau of Fire Protection-Baguio City, and the Bureau of Jail Management and Penology-Baguio City.

SECTION 5. THE CITY VALUES RESTORATION/ENHANCEMENT TEAM (CVRET). – For the implementation of this Ordinance, a City Values Restoration/Enhancement Team is hereby created to be designated by the City Mayor through an Executive or Administrative Order with a term of three (3) years unless revoked earlier and shall be composed of the following:

Co-Chairpersons:	- City Vice-Mayor
	- Chairperson of the Sangguniang Panlungsod (City Council) Committee on Ethics, Governmental Affairs and Personnel
Action Officer:	- City Human Resource Management Officer or his/her duly authorized representative
Members:	a. One (1) Values Restoration/Enhancement Focal Person:
	- All departments/offices of the City Government of Baguio;
	- Office of the Lone District Representative of Baguio City;
	- Liga ng mga Barangay, Baguio City Chapter;
	- Pederasyon ng mga Sangguniang Kabataan, Baguio City Chapter;
	- Baguio City Police Office;
	- Bureau of Fire Protection-Baguio City;
	- Bureau of Jail Management and Penology-Baguio City (Male);
	- Bureau of Jail Management and Penology-Baguio City (Female);
	- Schools Division Office, Baguio City; and
	- Public Information Office under the City Mayor's Office.
	a. Other members as may be deemed necessary by the CVRET, once convened by the City Mayor.

SECTION 6. DUTIES AND FUNCTIONS OF THE CITY VALUES RESTORATION/ENHANCEMENT TEAM (CVRET)

- a. Formulate a City Values Restoration/Enhancement (CVRE) Plan for the City Government of Baguio;
- b. Implement, in coordination with the Baguio City Character Council and the Civil Service Commission Values Restoration programs in accordance to the CVRE Plan;
- c. Recommend to the Sangguniang Panlungsod (City Council) of Baguio legislative support measures for the improvement of CVRE programs and activities;

SECTION 6. DUTIES AND FUNCTIONS OF THE CITY VALUES RESTORATION/ENHANCEMENT TEAM (CVRET)

- d. Submit to the City Mayor's Office and the City Council an annual report to include among others an assessment on the impact of CVRE Programs on the employee and the department/office taking into account their disposition, public rapport, productivity, conduct and ethical standards as indicators; and
- e. Performs such other related functions as may be assigned by the City Mayor or the City Council.

SECTION 9. THE CORE VALUES. – The Value Focus shall be based on the Civil Service Commission's identified core values of Patriotism, Integrity, Excellence, and Spirituality (PIES). It shall include the values synonymous to the same as provided for in Section 4 hereof. Moreover, it shall also include Filipino values and Cordillera cultural values aligned thereto, particularly, the values of Joy and Humor, Adaptability and Creativity, Faith and Religiosity, Hard-work and Industriousness, Resiliency, Family Orientation, and Hospitality.

School of Living Tradition (SLT) – defined as one where a living culture bearer, culture specialist, an elder and/or learned member of an ethnolinguistic groups who imparts to a group of young people from the same ethno-linguistic community or students in the various levels of the educational institutions, public or private, in the city, the indigenous cultural heritage which are allowed to be shared for learning, except those cultural heritage considered sensitive like rituals and practices practiced by elders or bearers.

SECTION 2. PURPOSES AND OBJECTIVES. – The School of Living Tradition (SLT) aims to:

-
- a. Provide an avenue for the students in the various educational institutions, both public and private, to learn and practice the Cordillera indigenous peoples' (IPs) cultural heritage, including history, songs, chants, dances, lifeways, among others;
 - b. Endeavor/encourage SLT learners to present what they have learned in various venues, including festivities, activities and the like, which are sponsored by the City Government of Baguio or their institutions that would help public awareness of these indigenous practices;
 - c. Develop adherence to the cultural sensitivity of these practices that are learned and practiced in the SLT;

SECTION 2. PURPOSES AND OBJECTIVES. – The School of Living Tradition (SLT) aims to:

- d. **Encourage teachers, staff, students and even their parents in the basic education to conduct researches, documentation and studies to further the knowledge, skills, and better appreciation of these practices under the SLT;**
- e. **Encourage interaction of students/schools with the community villagers, elders, learners, bearers for the appreciation of indigenous cultural heritage for their advocacy; and**
- f. **Seek support including funding from various offices, agencies, groups and individuals to sustain the programs on SLT by these educational institutions.**

SECTION 3. COVERAGE. – There shall be College Education Financial Assistance Grant in the amount of P6,000.00 each to those poor and underprivileged but deserving students every semester per school year who are enrolled and excel academically in schools located within the territorial jurisdiction of the City of Baguio.

SECTION 4. COMPOSITION OF THE BAGUIO CITY SCHOLARSHIP COUNCIL.

Chairperson: City Mayor

Vice-Chairperson: City Vice-Mayor

Members: All Sangguniang Panlungsod (City Council) Members

City Budget Officer

City Social Welfare and Development Officer

The council are tasked to implement the College Education Financial Assistance Grant Program under this Ordinance.

SECTION 6. APPLICATION AND SCREENING PROCESS

All applications shall be submitted to Baguio City Scholarship Council (BCSC) thru the City Mayor which shall make the evaluation, screening and selection in consultation and coordination with the concerned Scholarship Committee pursuant to this Ordinance and its Implementing Rules and Regulations (IRR). The Scholarship Committee shall have the duties and responsibilities of helping BCSC in recommending, screening, evaluating and selecting all students covered by this College Education Financial Assistance Grant Program.

SECTION 6. APPLICATION AND SCREENING PROCESS

The BCSC from time to time and whenever necessary shall meet or convene the Scholarship Committee in every school for the purpose of screening, evaluating, selecting and recommending the students covered by the College Education Financial Assistance Grant Program.

The BCSC shall submit to the City Mayor the list of the beneficiaries every semester per school year.

SECTION 8. TRANSITORY PROVISION

Pending the creation and composition of the Scholarship Committee in every school, the Baguio City Scholarship Council shall do the screening, evaluation and selection of the beneficiaries of the College Education Financial Assistance Grant Program under this Ordinance. The list of which shall be submitted to the City Mayor for his approval.

ORDINANCE Numbered 12 (Series of 2022)

AN ORDINANCE INSTITUTIONALIZING A COMMUNITY-BASED PEER TEACHING AND TUTORIAL PROGRAM FOR YOUTH AND STUDENTS IN THE CITY OF BAGUIO, PROVIDING FOR MECHANISMS FOR ITS IMPLEMENTATION, AND PROVIDING FUNDS THEREOF.

Section 3. Application. – This Ordinance shall be applied to all youth, student, learners and other education and youth empowerment stakeholders in the City of Baguio.

Section 4. Objectives. – The objectives of this Ordinance are the following:

- a. To ease the difficulty of youth and students in complying with their academic requirements;
- b. To encourage and engage the community to help learners/students continue their learning and ease the burden on parents who are possibly experiencing work-teach dilemma through the help of tutors;

SECTION 4. OBJECTIVES.

- c. Decrease the population of dropouts and failing students;
- d. To maintain the emotional, psychological and social well-being of the student in good condition; and
- e. Initiate youth and other stakeholders to be tutors

SECTION 5. CREATION AND COMPOSITION OF BARANGAY PEER SUPPORT GROUP. –
There shall be a created support group in the barangay for the implementation of this Ordinance and of which shall be composed of the following:

Chairperson :	- Punong Barangay
Vice Chairperson :	- Chairperson, Barangay Council Committee on Education
Action Officer :	- Chairperson, Sangguniang Kabataan
Members :	- Sangguniang Kabataan Kagawads
	- Unit Social Worker from the City Social Welfare and Development Office (CSWDO)
	- Local Youth Development Council (LYDC)
	- Religious Sector
	- Representative, (active teacher) from the Department of Education or representative from schools within or near the barangays

Section 6. Functions of the support group. – The Peer Support Group shall perform the following functions:

-
- a. Schedule tutorials and peer teaching;
 - b. Make progress reports of the students/tutees;
 - c. Coordinate with the Schools Division Office-Department of Education, Baguio City for the profiling of tutors and schedule of their orientation and training;
 - d. Submit report to the Schools Division Office-Department of Education, Baguio City; and
 - e. Perform such other functions related to the implementation of this Ordinance to be determined by the City Mayor as recommended by the Schools Division Superintendent (Schools Division Office-Department of Education, Baguio City).

Section 6. Functions of the support group. – The Peer Support Group shall perform the following functions:

- d. Submit report to the Schools Division Office-Department of Education, Baguio City; and
 - e. Perform such other functions related to the implementation of this Ordinance to be determined by the City Mayor as recommended by the Schools Division Superintendent (Schools Division Office-Department of Education, Baguio City).

AN ORDINANCE ADOPTING A
COMPREHENSIVE SPORTS
DEVELOPMENT CODE OF THE CITY OF
BAGUIO

SECTION 3. SPORTS DEVELOPMENT OBJECTIVES. - The City Government of Baguio aims to improve the state of sports in the City and achieve the following:

- a. To provide training and regular active participation of athletes, coaches and trainers in local, regional, Luzon-wide, national and international competitions;
- b. To scout, train and sustain potential athletes who are Baguio City born and to prepare them to represent the City of Baguio in various sports competitions in the county;
- c. The promotion of local sports in the City of Baguio which includes assisting in the building, upgrading and contract management of sports facilities, advertising by all means, conduct and promotion or sponsorship of tournaments, trainings, seminars, workshops, summits, clinics and conferences;

SECTION 3. SPORTS DEVELOPMENT OBJECTIVES. - The City Government of Baguio aims to improve the state of sports in the City and achieve the following:

- d. Hosting of national tournaments and planning of the year-round sports activities in coordination with all sectors of society including local chapters of National Sports Associations, clubs, associations, government agencies and private business organizations;
- e. Improving the benefits and privileges of local sports associations, city athletes and coaches in representing the City of Baguio to various multi-level sports competitions; and
- f. To promote the City of Baguio as a sports center in Northern Luzon.

SECTION 8. COMPOSITION. - The City Sports Council shall be composed of the following who are recognized to have greatly contributed to the development and promotion of Sports in the City of Baguio as identified herewith:

**Vice-Chairperson: Chairperson of the Sangguniang Panlungsod
Committee on Youth Welfare and Sports Development**

Action Officer: City Administrator

ARTICLE XIII
Cash Incentives to Athletes and Coaches in National Sports Competitions

SECTION 53. PRIORITIZATION FOR CASH INCENTIVES. – The Sports and Recreation Division shall ensure that the cash incentives program and other assistance and benefits that may be received by athletes and coaches from the City Government of Baguio, shall be prioritized to Baguio-resident athletes. In cases that no other Baguio-resident athlete is recognized or accepted, cash incentives may now be provided to winning Baguio-attached and affiliated athletes.

SECTION 54. CASH INCENTIVE FOR NATIONAL SPORTS COMPETITIONS. – This provides for the new cash incentive program to athletes in National Sports Competitions. By order of prioritization, Baguio-resident, Baguio-attached athletes, and Baguio-affiliated athletes shall be governed by this Section in the determination of their cash incentives for winning recognized national sports competitions. Likewise, it shall be applicable to Athletes with Disability (AWD) who participate and win in their respective sports disciplines as identified and recognized by the City Government of Baguio.

SECTION 55. QUALIFICATIONS FOR CASH INCENTIVE. – By order of prioritization, Baguio-resident, Baguio-attached athletes, and Baguio-affiliated athletes who are not officially or currently members of the national training pool but who have otherwise represented the City of Baguio in national competitions (lower class competitions) and has qualified to represent the country in international sports competitions; who win gold, silver and bronze medals in international sports competitions shall be entitled to cash incentives, provided, that:

- a. The athlete is born and traces his/her roots in Baguio City;
- b. Athletes whose parents (either mother or father) are Baguio City born; and
- c. Athletes whose families have settled permanently in the City of Baguio; Provided further, that they are part of the official roster of the Philippines for the competition.

SECTION 56. RATIONALIZATION OF CASH INCENTIVES FOR ATHLETES AND COACHES FOR NATIONAL SPORTS COMPETITIONS. – Athletes winning in national sports competitions shall not receive more than ₱60,000.00 of cash incentives within the same year. Coaches on the other hand shall not exceed ₱30,000.00 of total cash incentives within the same year.

ARTICLE XIV

Cash Incentives to Athletes and Coaches in International Sports Competitions

SECTION 57. INTERNATIONAL COMPETITIONS FOR INDIVIDUAL EVENTS.
– By order of prioritization, Baguio-resident, Baguio-attached, and Baguio-affiliated athletes is considered to have participated in international competition if he or she had participated in any of the following international sports events:

- a. Regular Major Competitions such as the Summer and Winter Olympic Games;
- b. Asian Games;
- c. Asian Winter Games;
- d. Southeast Asian (SEA) Games;
- e. Youth Olympic Games;
- f. Paralympic Games;
- g. Asian Park Games;
- h. Asian Indoor and Martial Arts Games;
- i. Asian Beach Games and Association of Southeast Asian Nations (ASEAN) Para Games; and
- j. International Federation of Muaythai Associations (IFMA) World Championship and World Youth Championship.

Ordinance 29-2021

PROVIDING FOR A MENTAL HEALTH
CARE AND DEVELOPMENTAL WELLNESS
PROGRAM FOR THE CITY OF BAGUIO
AND APPROPRIATING FUNDS THEREOF



SECTION 4. OBJECTIVES. – The objectives of this Ordinance are the following:

- a. Re-orient and modernize all mental health facilities in the city;
- b. Integrate mental health care in the general health care delivery system;
- c. Promote mental health, prevent, treat and control mental illness at all levels, and rehabilitate persons with mental disability;
- d. Provide free or inexpensive medicine and access to comprehensive health care and treatment both at the community and hospital level;
- e. Establish a multi-sectoral network for the identification and prevention of mental illness or disability and the management of mental health problems among vulnerable groups which include those affected by employment, illnesses/diseases, children, adolescents, elderly and those who are in need of special protection like survivors of extreme life experiences and violence, among others;

- f. Protect and promote the mental health of the people through a multi-disciplinary approach that covers health, education, justice, and social welfare;
- g. Institutionalize strong mental health and wellness policies within workplaces, schools and universities in the City of Baguio that would effectively cater to the needs of workers and students who are subjected to multiple factors affecting mental stability;
- h. Strengthen and improve referral systems to state and private institutions for the efficient and immediate delivery of mental health services;


- i. Fortify the rehabilitation and recovery services for all residents of Baguio City including those Persons Deprived of Liberty (PDL), Person with Disabilities (PWDs), persons who used drug and persons experiencing depression living with patients with Human Immunodeficiency Virus (HIV)/Acquired Immunodeficiency Syndrome (AIDS) disease as needed;
- j. Create and institutionalize an emergency psycho-social response team of the city that can be mobilized immediately during times of crisis, trauma, disaster, or calamities, which shall address the psycho-social concerns of affected individuals/groups/populations; and
- k. Recognize, regulate, support and protect the welfare and identity of the mental health advocates.

- Representative/s from religious sectors
- Representative/s from non-government organizations (NGOs) involved in mental health issues
- Representative from support groups or organizations operating in Baguio City
- One (1) representative from private health sector

- Representative from the Association of Private School Administrators-Baguio
- Representative from the Federation of Parents and Teachers Association of Baguio City
- Representative from the clients
- Other member/s as may be identified by the chair whose expertise and role may serve to effectively implement this Ordinance.
